Resolution – Approval of Agreement for Pro Bono Technical Advisory Services with Compact for America Educational Foundation, Inc., a Texas not for profit corporation ("CFAEFI"), including the appointment of CFAEFI, acting through its staff, including its relevant officers, board members, and advisory council members, as the Compact Administrator in accordance with Sections 4 and 6 of Article IV of the Compact, and establishment of the Compact Commission's primary place of business to coincide with that of the Compact Administrator. As provided by Article IV, section 6 of the Compact for a Balanced Budget, in its capacity as Compact Administrator, CFAEFI and its staff, including its relevant officers, board members, and advisory council members, are empowered to act as public officials, under the oversight and subject to the direction of the Compact Commission, with the power and duty: (a) to timely notify the States of the date, time and location of the Convention; (b) to organize and direct the logistical operations of the Convention; (c) to maintain an accurate list of all Member States, their appointed delegates, including contact information; (d) to formulate, transmit, and maintain all official notices, records, and communications relating to this Compact; and (e) keep the Commission seasonably apprised of the performance or nonperformance of the terms and conditions of this Compact. Pursuant to such powers and duties, the Compact Commission herewith authorizes and directs CFAEFI, acting through its staff, including its relevant officers, board members, and advisory council members: (a) to formulate and transmit and to assist the Compact Commission members in formulating and transmitting nonpartisan communications, which offer educational policy analysis, technical advice and expert testimony concerning the Compact for a Balanced Budget, to Congress, Member States and non-member States; (b) to assist the Compact Commission members in encouraging states to join the Compact for a Balanced Budget and Congress to call the Convention in accordance with this Compact; and (c) to assist the Compact Commission members in cooperating with any entity that shares a common interest with the Compact Commission and engages in policy research, public interest litigation or lobbying in support of the purposes of

the Compact. It is the intention of the Compact Commission that CFAEFI, acting through its staff, including its officers, board members, and advisory council members, as the Compact Administrator, shall qualify for exemptions from the lobbying registration laws of all relevant States and Congress based on: (a) the public official status of CFAEFI, acting through its staff, including its relevant officers, board members, and advisory council members, as Compact Administrator; (b) the uncompensated nature of CFAEFI's performance under the foregoing Technical Advisory Services agreement; (c) the fact that CFAEFI, as an entity, and the staff performing under the Technical Advisory Services agreement, including its relevant officers, board members, and advisory council members, personally, subscribe and shall only act as Compact Administrator while they continue to subscribe to the merits of the Compact for a Balanced Budget; and/or (d) based on requests by legislators or registered lobbyists for expert testimony or technical advice concerning the Compact for a Balanced Budget. A copy of the agreement is attached. It is understood that CFAEFI serves as Compact Administrator at the pleasure of the Compact Commission.
