The Constitution mandates a convention call for each set of two thirds application by the states. The fact sufficient applications existed to cause two convention calls during the same year has no bearing on the requirement to call. Had Congress actually obeyed the Constitution and thus addressed this issue at the time, most certainly it would have separated the two conventions so each was held in a different year).
